**Lighting Requirements on Beaudin Blvd. North**

The Committee Members discussed the hiring of a casual labourer to tend to watering the hanging flower pots and mowing of grass at Joe’s Park and the Cartier Health Centre. Position would, at a maximum, require three hours a day – three days a week.

**Paving of Beaudin Blvd. North**

As there are still a number of vacant lots, paving will not be undertaken this year. Past policy has been that paving occurs once 90% of the lots are filled to prevent premature road deterioration.
